## **OPPORTUNITIES AVAILABLE FOR AGRICULTURE SCIENCE STUDENTS AND FFA MEMBERS**

As a student enrolled in the Medina Valley Agriculture Science Program, your child has the opportunity to become a member of the Medina Valley FFA chapter. This is a group of young people who use agriculture to learn leadership, speaking and communication skills, teamwork, responsibility, and technical skills. While the FFA is based in agriculture, there are many activities to become a part of that do not require working with animals or agriculture.

In the fall FFA members compete in FFA Leadership Development Events (LDEs) such as Skills Demonstrations, Agricultural Advocacy, Parliamentary Procedure, Public Relations, Job Interview, and many other speaking and leadership type events. Most animal projects are also started in the fall or summer months and are called FFA Supervised Agricultural Experiences (SAEs).

During the spring time FFA members start to prepare for Career Development Events (CDEs) or also known as judging season. The speaking competitions take place in late spring and are called Speaking Development Events (SDEs). FFA members travel to many locations throughout the state for competitions in the spring. January through March also brings several livestock shows for animal project competition. Each year Medina Valley FFA members bring home thousands of dollars in prize money and scholarships from these shows and contests.

Through the years agricultural education has changed from training young men for a career in farming to a dynamic, progressive way to teach all students the value of leadership and teamwork to achieve success. Agriculture is the most important industry in the world – without the ability to feed people, the United States would not be the world power it is. The FFA also offers many large scholarships for highly active members.

It is our sincere hope that your student will take full advantage of the unbelievable activities available through these courses and the FFA organization. ## **GENERAL RULES**

Each student enrolled in an agriculture science class is encouraged to join the Local, District, Area and National FFA Organization (FFA). Dues are \$25 per year and must be paid by Wednesday, October 4, 2023. Students who do not join FFA are not eligible to participate in any FFA activity, judging contest, livestock show, or for scholarship consideration. All members are encouraged to attend all FFA meetings and activities. Parents are also encouraged to join and participate in booster club activities. Any student with frequent discipline issues can be removed from the program if they are involved with ISS or DAEP. Students must be University Scholastic League eligible to compete in any component of the Medina Valley FFA. In order to be a FFA member, students at Medina Valley High School must enroll in at least one AFNR course per semester each school year.

## **LIVESTOCK PROJECTS**

Students enrolled in the Agriculture Science Program are eligible to participate in the livestock project program. Students may purchase animal projects to care for during the school year and exhibit those animals at stock shows. Students may keep the projects at the Medina Valley FFA Project Center (our school farm) or in most cases the animal can be kept at home. These projects allow students to take on responsibility while having the opportunity to practice the skills learned in class and maybe even earn a little money. Animal projects are not mandatory so the following questions should be considered when determining if a student will participate in the animal project part of the program:

- Can the student or parent afford the project?
- Where will the project be kept?
- Will the student have transportation to and from the animal for care?
- Does the student have means of transporting the animal(s) to and from events?
- Is the student able to care for the animal the entire length of the project? Holidays? Weekends?

Please keep in mind animal projects are a gamble and can become a total monetary loss. Animals can be hurt, fatally injured, or become sick and not recover. The risk can be reduced by hard work, proper management, and desire to learn and apply knowledge.

## **PURCHASING OF LIVESTOCK PROJECTS**

The selection and purchase of an animal project is a cooperative effort involving the student, parent, and teacher. The purchase of projects should be coordinated with the teacher before projects are selected and purchased. The student and parent are responsible for all costs associated with the livestock project. Projects purchased must meet the requirements of the show intended. The teacher will assist in providing the necessary information regarding the care and grooming of projects for each show. In the event a check is returned for non-sufficient funds, only cash or a cashier's check will be accepted for project payment.

The student and parent is responsible for:

- The daily care of their project.
- Informing the teacher regarding any problems and/or progress of the project.
- The entry and validation fees needed for all stock shows.
- The payment of feed, animal costs, and veterinary care.
- Attendance at all mandatory barn clean ups from start to finish.
- Cleanliness of individual pen and barn.

The agriculture science teacher is responsible for:

- Any problems that may occur with the animal project during normal working hours. The teacher is not required to make emergency calls after hours for the purpose of treating sick or injured animals. However, the teacher will make every effort to assist when needed with those problems. Please call a veterinarian if necessary.
- The teacher will visit projects in accordance with Texas Education Agency guidelines.
- Recommending feeding programs for each animal project area.
- Livestock show participation is not a requirement of the program, therefore it cannot be guaranteed that teacher supervision will be available at every show. Every effort will be made for the teacher to attend shows.
- The teacher will assist in giving medications when possible. The teacher will not be held liable for injury to livestock while assisting the student with their project. This includes giving medication, castration, dehorning, docking, worming, trimming or any other activity directly involving the teacher. The FFA advisors prefer that these procedures be done by a veterinarian.

Chain of Command: All questions and concerns regarding animals and the FFA should first be addressed with the supervising advisor. If that does not satisfy the issue then a meeting may be scheduled with all FFA advisors and an administrator. Please communicate with your agriculture science teachers.

### **LIVESTOCK PROJECT PARTICIPATION**

To show an animal project a student must be a member of the Medina Valley FFA. In order to participate in a FFA project show, students must be passing all courses as determined by Medina Valley ISD. Students whose projects are not ready or are not of sufficient quality to participate in a show will not be allowed to show. This decision will be made by the teacher. A list of eligible students will be prepared by the teacher to authorize attendance at the show. Any student that attends on an unassigned day will be reported as truant. The parents and student will make arrangements with the teacher for supervision at major shows. Students and parents are responsible for transportation, lodging, and costs at livestock shows. School policies and discipline will be enforced and will be according to school policies. Students who fail to follow rules at shows or contests will be removed from the eligibility list and barred from future participation. School dress code will be enforced at all times. In order to be a FFA member, students at Medina Valley High School must enroll in at least one semester of an agriculture science class each school year. Medina Valley FFA will comply with the Texas FFA/4H Code of Ethics Policy.

### **CODE OF ETHICS**

Agriculture science students will honor the FFA Code of Ethics. Failure to comply with the code of ethics will result in removal from the program. Students will conduct themselves at all times in a manner befitting their organization, chapter, school and community by:

- Dressing neatly and appropriately for the occasion.
- Showing respect for the rights of others and being courteous.
- Being honest and not taking unfair advantage of others.
- Respecting the property of others.
- Refraining from loud, boisterous talk, swearing, and other unbecoming conduct.
- Demonstrating sportsmanship in the show ring, judging contests, and meetings.
- Attending meetings promptly and respecting the opinion of others in discussions.
- Taking pride in the Medina Valley FFA.

## **ANIMAL PROJECTS AT HOMES**

When the facilities are adequate, some students may decide to raise livestock projects at home. When making this decision, consider the following:

- It is highly recommended that only experienced feeders keep their animals at home.
- Students must be able to provide transportation for animals to shows, validations, and veterinary visits.
- Selection is the most important part of your animal project. Please communicate with your agriculture science teachers.

## **BOOSTER CLUB ACTIVITIES**

The **Medina Valley FFA Booster Club** is responsible for raising funds to support FFA events and to offer graduating seniors scholarships. All supporters of the FFA are highly encouraged to attend. Families must pay annual dues to have voting rights.

## **JUNIOR FFA MEMBERSHIP**

Junior FFA is a statewide organization with the purpose of enhancing and encouraging the education of younger students. The organization of the Junior FFA is entirely optional with the need of such an organization to be determined by the local school district. Junior FFA is for Medina Valley ISD students enrolled in grades 3-8 only that are the sibling of a student that is currently a member of the Medina Valley FFA or who was a Junior FFA member before their sibling graduated. Children of Medina Valley ISD employees are also eligible for membership.

Junior FFA member dues are \$25 per school year and are due on Wednesday, October 4, 2023. Junior FFA members must meet the same requirements and follow the same rules as FFA members. Junior FFA members are not permitted to vote at meetings. Junior FFA members must attend mandatory FFA activities to include barn clean ups and county show set-up and clean-up if they show livestock. It is recommended that Medina Valley Junior FFA members are also members of the local 4-H club. The local 4-H club is able to offer more opportunities for involvement. Please contact the Medina County Extension Office to identify who the 4-H leaders are for your region.

### **FFA OFFICER TEAM**

The Medina Valley FFA hosts officer elections during the month of April. To become an officer in the Medina Valley FFA, students must be in good academic standing. Scores are comprised of a scored application weighted at 50% and a membership vote weighted at 50%. Outgoing seniors do not have voting rights regarding the next year's officer team. Members must be present on balloting day to vote. The incoming FFA officers are installed at the annual FFA banquet. Campaigning in the form of social media posts, passing out brochures, candy, or treats is prohibited. Failure to comply to campaigning policy may result in disqualification of application.

### **FFA LETTERMAN JACKET CRITERIA**

In order to qualify for a letterman jacket, FFA members must obtain one of the following goals: place top three in area or be a state qualifier in a Leadership Development Event, qualify for state, or if automatically qualified, be top ten in the state in a Career Development Event, qualify for state in a Speaking Development Event, or place top three in the state in the Agriscience Fair. The Medina Valley FFA will only pay for the cost of the letterman jacket. Any extras ordered are the financial responsibility of the student and their family.



**MEDINA VALLEY FFA FACILITIES AGREEMENT**  
**ONLY NECESSARY IF HOUSING LIVESTOCK AT PROJECT CENTER**

***Please submit \$50 per animal (this fee is per project and not per pen).***

1. All policies of Medina Valley ISD governing students' conduct apply to students. This includes policies governing smoking, illegal weapons, and alcohol for any person on school property.
2. Students and parents are responsible for transportation to and from the facilities.
3. Use of tobacco, alcohol, or vaping by students or parents on the premises can result in immediate removal of the student and project.
4. Each student is responsible for keeping his/her pen, the surrounding area, and any assigned areas clean. Pens must be cleaned on a daily basis.
5. Each student is responsible for feeding and general care of his/her project. Students may not feed animals that do not belong to them unless prior arrangements have been made with the owner or agriculture science teacher.
6. Each and every student who uses Medina Valley facilities is expected to attend all workdays from start to finish or can send a family representative in the event of a time conflict.
7. A student should not be in another student's pen unless permission is given by teacher, owner, or parent.
8. Firearms, pets, and dogs are prohibited.
9. Projects are considered complete within seven days of the student's last show and must be removed from the facilities.
10. If it becomes necessary to remove a student's animal, the owner will have three days to remove the animal. If the animal is not removed at that time, it will be taken to auction at the owner's expense. The remainder of the money from the sale of the animal will be sent to the owner after the pens have been fully cleaned and sanitized.
11. Only students currently enrolled in the Medina Valley FFA Program are eligible to use the Medina Valley FFA facilities. Students not enrolled in the program should not loiter at the facilities.
12. Visitors with any member must have approval with the agriscience teacher prior to visit. Any unapproved visitor can be cited for trespassing by Medina County Sheriff's Department. Agriculture science teachers have the right to remove and ban any visitors from the facilities.
13. Animal pens must be cleaned within seven days after the project is completed. All students using the facilities must attend all workdays determined by the teachers. Failure to attend all workdays or clean pens could result in checks being held or being denied the privilege of using the facilities in the future.
14. No mechanical, wooden, electrical, or metal structures may be placed in pens without the teacher's approval.
15. Students who are present must be working with their animal or cleaning pens.
16. Students and parents must observe opening and closing times for the facilities. The hours are 5:00am to 9:00pm.
17. The FFA advisors will use their best discretion to assign pen assignments.

18. Upon paying project center pen rent, families will receive key cards to swipe to gain access to the facility. All key cards must be returned within seven days of their last livestock show. Failure to return key cards may result in a fee of \$25 per key card. Exhibitors and families may only enter the facility at the designated gate using their key card. Climbing fences or entering the facility without the key cards may result in loss of facility use.
19. Animals kept at the school farm are raised for livestock production purposes. The Medina Valley FFA Facilities are not a permanent home for animals. Family domestic animals do not meet the required project criteria. Only sheep, goats, and swine can be housed at the Medina Valley FFA Project Center. Rabbits, cattle, and poultry may be exhibited through the Medina Valley FFA, but must be kept at home.
20. Families parking at the Medina Valley FFA facilities are to park in the parking lot and not in the street or in the grass.

COVID-19 Addendum
